- Note : 1. Labor to apply for monthly pension was approved for the first time, since receipt of the application for the following month until issued to the quarter ended, after a regular basis every February, May, August, November quarterly payment.
2. The newly amended and effective Labor Pension Act of January 17, 2014, includes spouses of Taiwan nationals from China, Hong Kong, Macau and other foreign countries who are legally working or are self-employed in Taiwan as contributors to the pension plan. Self-employed spouses are calculated by the number of persons and not by the number of business units. Pension payment includes those under 60 who have lost the capacity to work and met the conditions for early pension payment.
3. The Act for the Recruitment and Employment of Foreign Professionals was enacted as of February 8, 2018. According to Article 11 of the Act, the new labor pension system shall from that date be applicable to foreign professionals who are hired to engage in professional work and who have obtained permanent residence.
4. The data of "Area" is classified by the location of the enterprise register and the self-employed operators' household register. Self-employed operators aren't included in data of units.
